GENERAL INFORMATION REGARDING THIS APPLICATION

- Application Form:** Type or print in ink, not pencil. Students who have attended WOU or another school under a different name must indicate it in the name section of this form. Submit form to the Office of Admissions, Western Oregon University, 345 N. Monmouth Avenue, Monmouth, OR 97361.
- Application Fee:** A non-refundable \$50 fee must accompany this application. Students receiving an **undergraduate degree from WOU are not required** to pay the application fee unless they are applying for graduate admission. Make check or money order payable to Western Oregon University.
- Official Transcripts:** Have the registrar from every college or university previously attended send an official transcript to: Office of Admissions, Western Oregon University, 345 N. Monmouth Avenue, Monmouth, OR 97361. Transcripts are required from all institutions previously attended even if credit was not earned. To be considered official, a transcript must be sent directly to the Office of Admissions from the issuing institution and bear the official seal or designation of the school. For WOU graduates with an established permanent file, student copies of the transcripts are acceptable. Students ineligible to return to previous schools will not be accepted by WOU. Transcripts submitted become the property of Western Oregon University and cannot be returned.
- Tests Required:** Scores from the Miller Analogies Test or general Graduate Record Examination are required if the student has a grad-point average of less than 3.00 for the last 60 semester (graded A-F) hours or 90 quarter (graded A-F) hours of undergraduate work. Please submit official scores to Office of Admissions, Western Oregon University, 345 N. Monmouth Avenue, Monmouth, OR 97361.
- Admission Status:** Students may attend summer sessions before being formally admitted to the University. However, to earn a degree, to be recommended by the University for a Teaching Endorsement, to receive financial aid, or to enroll for 8 or more quarter hours during fall, winter, or spring term, you must be admitted to the University officially.
- Post-Baccalaureate/Undergraduate Applicants:** Students in this category elect to be considered undergraduates for fee assessment purposes. They are limited to taking **only undergraduate courses**. Undergraduate tuition will be charged for these programs. Courses taken through this option cannot be applied toward a master's degree program.
