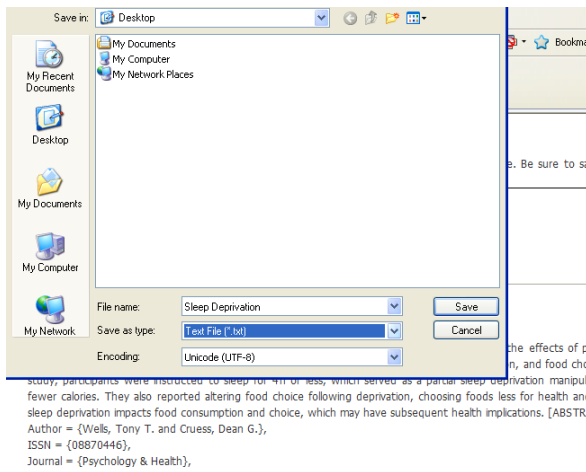
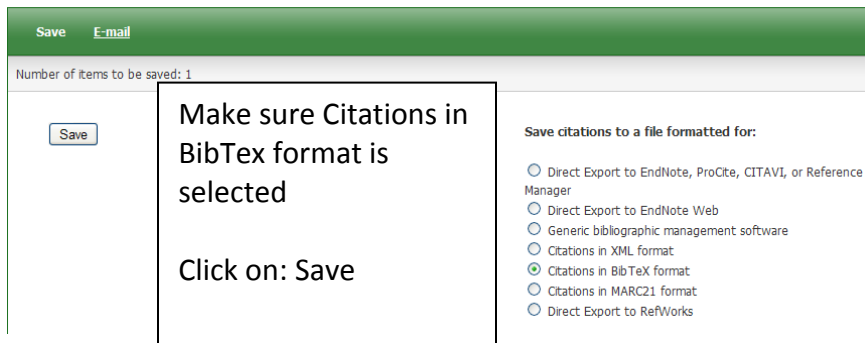
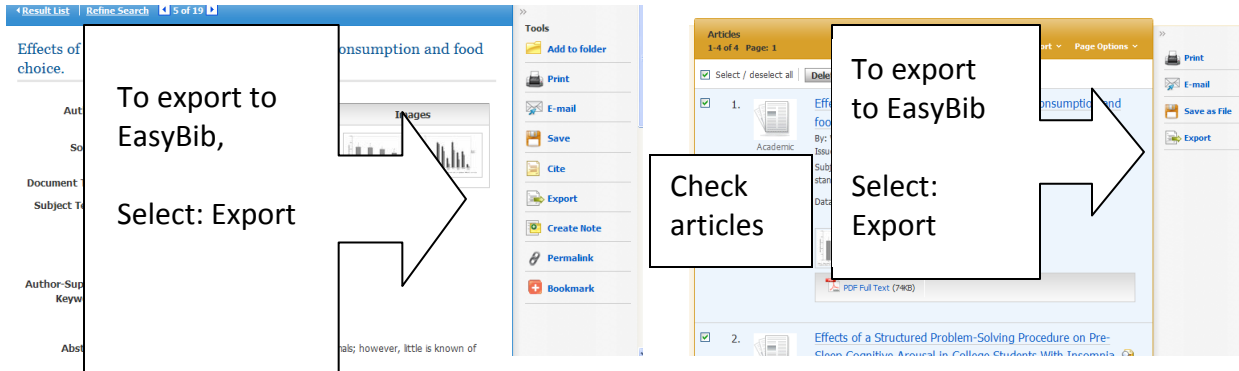


Exporting Citation to EasyBib – From Academic Search Premier (or any EBSCO database)

From an individual article:

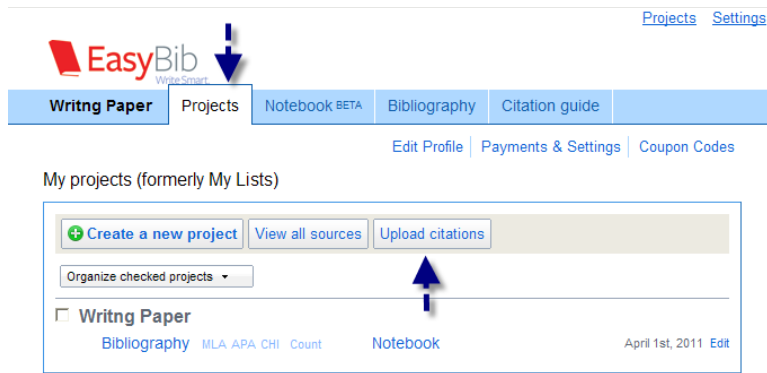
From a Folders List:



In any Ebsco Database, you need to save the file as a Text (TXT file)

From the top of the screen

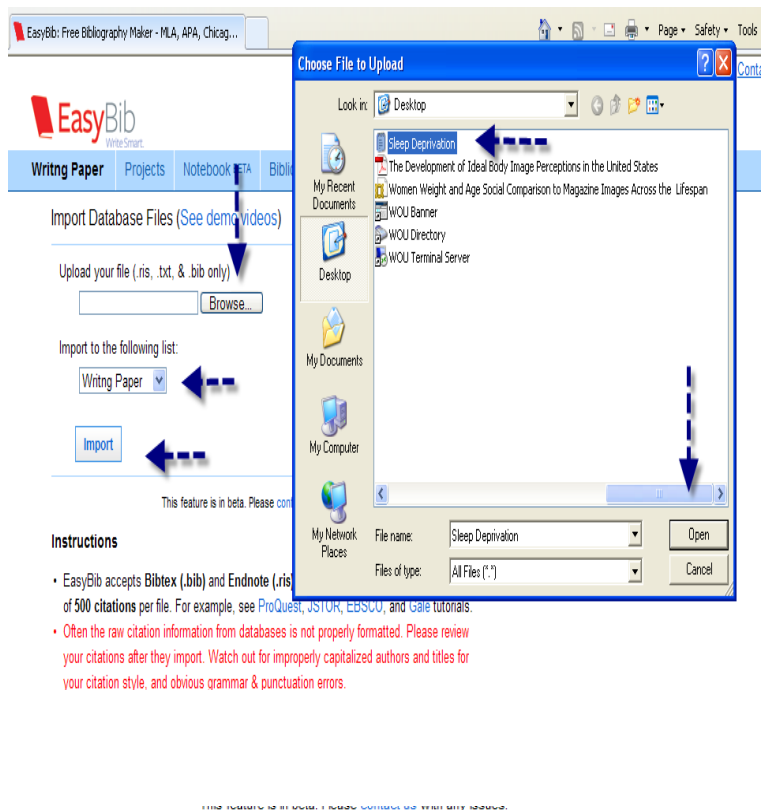
- + Select: File
- + Select: Save As....
- + Change Save in to My Documents or a USB Drive (if you are using one)
- + Change File Name to something you will recognize
- + Change Save As Type to Text File (TXT)
- + Click on Save button



Open up Easy Bib

Select: Project

Select: Upload Citations



Select: Browse

Find the saved Text File of the article citation on your computer

Select: Open

Change: Import to the following list to the project you want the citation sent to.

Instructions

- EasyBib accepts **Bibtex (.bib)** and **Endnote (.ris)** file formats. You may upload a maximum of **500 citations** per file. For example, see [ProQuest](#), [JSTOR](#), [EBSCO](#), and [Gale](#) tutorials.
- Often the raw citation information from databases is not properly formatted. Please review your citations after they import. Watch out for improperly capitalized authors and titles for your citation style, and obvious grammar & punctuation errors.
